BY-LAW 2014-76

being a by-law to designate the memorial stained glass windows at St. John's United Church, 50 Bridge Street West, Campbellford, as being of cultural value or interest

WHEREAS the Ontario Heritage Act, RSO 1990, Ch. O.18, Section 29, as amended, authorizes the council of a municipality to enact by-laws to designate real property, including all buildings and structures thereof, to be of cultural value or interest;

AND WHEREAS the Council of the Corporation of the Municipality of Trent Hills has provided notice to the owner of the memorial stained glass windows at St. John's United Church, 50 Bridge Street West, Campbellford, and upon the Ontario Heritage Trust, intention to designate the windows and has published notice in a newspaper having general circulation within Trent Hills;

NOW THEREFORE THE COUNCIL OF THE MUNICIPALITY OF TRENT HILLS ENACTS AS FOLLOWS:

- That the memorial stained glass windows at St. John's United Church, 50 Bridge Street West, Campbellford, were designated as having cultural heritage value and interest for the reasons outlined in Schedule "A" attached hereto and forming part of this by-law.
- That the Municipal Clerk is hereby authorized to cause a copy of this by-law together with the reasons for designation attached hereto as Schedule "A" be registered on title of the property described above in the proper Land Registry Office;
- That the Clerk is hereby authorized to cause a copy of this by-law to be provided to the owner of the aforesaid property and to the Ontario Heritage Trust and to cause notice of the passing of this by-law to be published in a newspaper having general circulation in the Municipality.

SCHEDULE "A"

TO BY-LAW 2014-76

STATEMENT OF CULTURAL HERITAGE VALUE OR INTEREST

Description of Property: St. John's United Church, 50 Bridge Street West,

Campbellford Block B, Plan 112.

Element to be Designated: Memorial Stained Glass Windows.

This Statement of Cultural Heritage Value or Interest applies to a series of thirteen (13) stained glass windows, twelve (12) of which were created by Christopher Wallis of Christopher Wallis Stained Glass Ltd. The 13th window above the choir loft was restored by Mr. Wallis in 1993. This window was originally installed by Luxifer Prism Company in 1950.

Eleven of the twelve other windows follow a plan created by Mr. Wallis depicting various key stories from the Bible about the life of Jesus Christ. These designs also depict various symbols of the United Church of Canada, the Christian church or United Church Women.

These windows represent not only a key historic and architectural feature of the church but the work of a renowned artist. He was born, took his training and began his career in London, England. He emigrated to Canada in 1956 and founded his first studio in London, Ontario in 1959.

Mr. Wallis' work appears in many public buildings from Victoria to Ottawa in such building as the Rideau Hall, RMC Sandhurst, Osgoode Hall , and Government House in Victoria.

Mr. Wallis was awarded the Commemorative Medal at the time of Canada's 125 Anniversary for his significant Contribution to Canada.

The detail from one of his windows showing the Madonna and Child was chosen by Canada Post in 1997 to be featured as an International Christmas stamp.

The key aspect of the windows at St. John's United Church was that the windows appear as one design from the exterior but work as a duplexed depiction inside the church due to the separation created by the balcony.

The windows make use of English and European handmade antique glass. Colours are unique to each vignette yet are repeated in the window in the opposite side.
