### SCHEDULE "A" TO BY-LAW 2011-

#### STATEMENT OF CULTURAL HERITAGE VALUE OR INTEREST OF 29 FRONT STREET, HASTINGS

##### DESCRIPTION OF PROPERTY

29 Front Street East, Hastings, is a commercial building on the north side of Front Street East in the Village of Hastings, now part of the Municipality of Trent Hills.

##### STATEMENT OF CULTURAL HERITAGE VALUE OR INTEREST

The cultural heritage value of this building lies in the existence of the front porch circa 1880. It is the last remaining porch in the business district of the Village of Hastings. The porch is comprised of wooden shingles, tongue and groove ceiling and turned posts and spindles.

It also features a six panel front door framed by inset sidelights and glazed transom. The building is constructed of red clay brick of triple wall construction in a pattern of common bond.

The cultural heritage value also lies in its association with the commercial history of the Village. Commissioned by Henry Fowlds and built by McDonald and Bartlett, it originally served as the Albion Hotel, a boarding house for lumbermen who worked along the Trent River. It later became the home and office of Richard Coughlan, Hastings' first medical doctor. It later served as a bakery, Legion hall, antique shop and artist studio. It is now used as a guest house.

##### DESCRIPTION OF HERITAGE ATTRIBUTES

- Random rough limestone foundation
- Red clay brick in common bond with header course
- Six panel front door with inset sidelights
- Glazed transom with three pieces of original glass and red detailing
- Porch with wooden shingles, tongue and groove ceiling and turned posts
