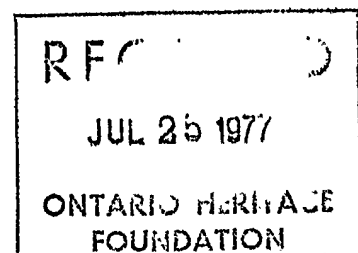


Take notice that the Council of the Corporation of the Village of Neustadt, on the 4th day of July, 1977, decided to designate the lands and building, known municipally as the Creamery, on Jacob Street, West, as a property of historical value or interest under the Ontario Heritage Act, 1974, 1974 S.O. Chapter 122.

Short Statement of the Reasons for the Proposed Designation:

Huether's Brewery (Later Neustadt Creamery) was built in 1869 by the late Henry Huether. Huether's Brewery is recommended for designation for its historical association with the founding of this municipality. This beautiful stone building was erected on a natural rock foundation and vaults were hewn out of the rock, which provided cooling facilities for the famous Huether beer.

Notice of objection to the designation may be served on the Clerk within thirty days of the 18th day of July, 1977.
