NOTICE OF INTENTION TO DESIGNATE

Take notice that the Council of the Corporation of the Municipality of West Perth intends to designate the property at the following municipal address as a property of architectural and historical value under Part IV of the Ontario Heritage Act, 1990, c.O.18, s.29(3)

> Plan 341, Part Park Lot 54 98 Huron Rd. Mitchell Ward Municipality of West Perth

Reason for the proposed designation:

This late 1870 Gothic is an excellent example of Victorian-Italinate architecture, yellow brick, two and one half storey. It was once owned by the Mitchell Advocate founder (Wm. Davis). Mrs. Davis (nee Tabitha Worth, 1945) was the daughter of Thomas Worth, the area's first settler.

There are three gables at the front of the house, one large in the center and two smaller gables – one on either side of the center gable. Each gable is mounted with a finial at the top and is decorated with gingerbread or bargeboard. The front entrance is centered and set forward from the rest of the house at six feet. The windows on the second storey are arched and the windows on the first level are curved slightly upwards on the top. The front door is bordered by sidelights and a curved transom above. All the windows are highlighted by a fine formed concrete decoration, extending down the sides.

The designation will include the front, the east and west sides of this home.

Any person may within thirty days of the publication of this notice, send by registered mail or deliver to the Clerk of the Municipality of West Perth notice of his or her objection to the proposed designation together with a statement of the reasons for the objection and all relevant facts.

If such a Notice of Objection is received, the Council of the Corporation of the Municipality of West Perth shall refer the matter to the Conservation Review Board for a hearing.
