# THE CORPORATION OF THE CITY OF ST. THOMAS ONTARIO HERITAGE ACT, R.S.O. 1990, c. 0.18

Section 29(6) of the Ontario Heritage Act, R.S.O. 1990, c. 0.18 provides that where no notice of objection to a proposed designation is served within the prescribed thirty day period, Council may either pass a by-law designating the property or withdraw the notice of intention to designate the property.

CITY OF ST. THOMAS

BY-LAW NO. 145-92

A by-law to designate 77 Metcalfe Street, in the City of St. Thomas, as a building of historic and architectural value.

WHEREAS pursuant to the Ontario Heritage Act, R.S.O.

1990, c. 0.18, the Council of a municipality may by by-law
designate a property including buildings and structures
thereon to be of historic or architectural value or interest.

AND WHEREAS notice of intention to designate the property at 77 Metcalfe Street, St. Thomas, Ontario, has been duly published and served, and no notice of objection has been received to such designation;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF ST. THOMAS, ENACTS AS FOLLOWS:

- 1. There is hereby designated as being of historic and architectural value or interest the municipal residence known as 77 Metcalfe Street in the City of St. Thomas, in particular, the west external wall, all of which is described in Schedule "A" attached hereto, for the reasons set out in Schedule "B" attached hereto.
- 2. The City Solicitor is hereby authorized to cause a copy of this by-law to be registered upon the title to the property described in the aforementioned Schedule "A" in the proper Land Registry Office.
- 3. The City Clerk is hereby authorized to cause a copy of this by-law to be served upon the owner of the aforesaid property and upon the Ontario Heritage Foundation and to cause notice of this by-law to be published in the St. Thomas Times-Journal.
- 4. This by-law comes into force on the day it is finally passed.

### DESCRIPTION

City of St. Thomas, County of Elgin, being part of Lot No. 3 east of Metcalfe Street, Plan No. 190, described as follows:

COMMENCING at a point in the westerly limit of said lot 3, distant 50 feet north from the southwest angle of said lot 3;

THENCE Easterly parallel to the southerly limit of said Lot 3 to a point in the easterly limit of said lot 3;

THENCE Northerly along the easterly limit of said lot 3 to the northeast angle of said lot 3;

THENCE Westerly along the northerly limit of said lot 3 to the northwest angle of said lot 3;

THENCE South along the westerly limit of said lot 3 to the point of commencement.

Being the lands lastly described in Instrument 185248.

#### SCHEDULE "B"

# 77 Metcalfe Street

This two storey house was built by Benjamin Drake, one of the pioneer settlers of St. Thomas. Colin Munro, an early sheriff of Elgin County, owned the house from 1865 to 1873.

The building is in the neo-classical style, with five bay windows which are shuttered, and a hip roof. The central door has side lights and an elliptical transom. There is a Greek temple porch with elliptical fascia. The eaves on the house are plain. The bricks appear to be handformed and of a similar rose colour to other local brick houses of the same era.
