**THE CORPORATION OF THE CITY OF ST. THOMAS
ONTARIO HERITAGE ACT, R.S.O. 1990, c. O.18**

Section 34(1) of the Ontario Heritage Act, R.S.O. 1990, c.0.18 provides that no owner of property designated under municipal heritage designation shall demolish or remove a building or structure on the property or permit the demolition or removal of a building or structure on the property unless the owner applies to the council of the municipality in which the property is situate and receives consent in writing to the demolition or removal.

TAKE NOTICE THAT the Council of the Corporation of the City of St. Thomas on the 17th day of March, 2003 under Section 34(2)(a)(ii) refused the application from Alma Heritage Estates Corporation for the demolition of Alma College and Chapel at 96 Moore Street.
