

To Amend By-Law 3-95, Being a By-Law
to Designate a Certain Property As Being
of Historic and/or Architectural Value or Interest -

WHEREAS the Council of the Town of Markham, at its meeting held on June 24, 1997, by the adoption of Item 8 of the Tenth Report of the Planning and Development Committee, passed a resolution to revise Schedule 'A' of By-law 3-95, to correct the legal description of The David Break House);

AND WHEREAS the Council of the Corporation of the Town of Markham has caused to be served on the owners of the lands and premises as outlined hereunder:



1. THAT Schedule 'A' of By-law 3-95 be replaced with revised schedule attached hereto.


