NOTICE OF INTENTION TO DESIGNATE

Take notice that the Council of the Corporation of the Town of Markham, on the 14th day of February, 1978, passed a motion of intention to designate the property, including lands and buildings, known municipally as 4 Leahill Drive, Thornhill, Ontario, as a property of architectural and/or historical interest or value under Part IV of The Ontario Heritage Act, 1974, R.S.O. Chapter 122.


Short Statement of the Reasons for the Proposed Designation:

The Edey House at 4 Leahill Drive, Thornhill, is recommended for designation for architectural reasons as an excellent example of Regency Classical Revival style. The storey and a half stucco house is five bays wide. The main entrance in the central bay has a broad gable above it. The pointed arch window in this gable opens onto a balcony of cast iron treillage. Wooden pilasters are set between the windows on the main facade and support a heavy architrave under the eaves.

John Edey built the house in 1845. It was originally located on the west side of Yonge Street and was moved in 1966 when it was restored under the direction of Napier Simpson.

Notice of objection to the designation may be served on the Clerk within thirty(30) days of the 8th day of March, 1978.
