## NOTICE

IN THE MATTER OF THE ONTARIO HERITAGE ACT, R.S.O. 1980, C. 337, AND IN THE MATTER OF THE LANDS AND PREMISES, KNOWN AS THE "STREETSVILLE UNITED CHURCH", LOCATED AT 274 QUEEN STREET SOUTH (STREETSVILLE), IN THE CITY OF MISSISSAUGA, IN THE PROVINCE OF ONTARIO.

### NOTICE OF INTENTION

#### TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the City of Mississauga, intends to designate the exterior of the original Streetsville United Church building and its real property but not to include additions to the north and west facade located at 274 Queen Street South (Streetsville), in the City of Mississauga, in the Province of Ontario, as a property of architectural value and historical interest under Part IV of the Ontario Heritage Act, R.S.O. 1980, c. 337.

#### REASONS FOR THE PROPOSED DESIGNATION:

The exterior of the original Streetsville United Church building located at 274 Queen Street South (Streetsville), is recognized on the Mississauga Heritage Inventory and is recommended for designation on the architectural grounds that it is an innovative example of the High Victorian Gothic Style for churches, with its picturesque turrets and spires, its polychromy in brick and stone, particularly the east gable decoration, its combination of textures of smooth, and corbelled or molded brick and smooth, molded, or rough rusticated stone. The steep roof, buttresses, and practical protective water tables are integral to the style. At the street level on the east facade is a centre door with a segmentally-arched head, blind wooden tympanum with a stained glass insert, and two panes of brick surround. A very large window, the same shape as the door openings, with similar stone course moldings, is located above the door. Historically, the Methodist congregation is almost as old as Streetsville itself, predating this building by fifty-five years. Given its prominent siting, the church has been a landmark on Queen Street for over one hundred years.

### NOTICE OF INTENTION

#### TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the City of Mississauga, intends to designate the property, meaning the real property and including all buildings and structures thereon, of the "Streetsville United Church Parsonage" located at 20 Barry Street (formerly William Street, Streetsville) in the City of Mississauga, in the Province of Ontario as a property of historical interest and architectural value under Part IV of the Ontario Heritage Act, R.S.O. 1980, c. 337.

#### REASONS FOR THE PROPOSED DESIGNATION:

The "Streetsville United Church Parsonage" located at 20 Barry Street (formerly William Street, Streetsville), is recognized on the Mississauga Heritage Inventory and recommended for designation for its architectural and historical importance. Architecturally, the "Old Parsonage" is a fine example of the Italianate style, popular in Ontario from the 1840's through the 1880's. Architectural features noteworthy of preservation include: the low pitched hipped roof with wide eaves and paired brackets; the dormer window, bay windows and original fenestration; segmental window heads; the dichromatic brickwork, the central door and door surround of the main facade; the front porch.

Historically, this structure was built circa 1880 by the Methodist Church of Streetsville (now the United Church) as a parsonage.
