## NOTICE OF INTENTION TO DESIGNATE

Under the Ontario Heritage Act R.S.O. 1990, c. O.18,

TAKE NOTICE THAT the Council of The Corporation of the Municipality of Kincardine intends to repeal designating By-law No. 4144 (former Town of Kincardine) which designated Victoria Park (Durham Market Square), under the Ontario Heritage Act 1974, as a property of architectural value or interest in order to update the designation as a property of cultural heritage value or interest under section 29 of the Ontario Heritage Act.

PROPERTY: 707 Queen Street (Victoria Park and Kincardine Centre for the Arts), Former Town of Kincardine, Kincardine ON

REASONS: The designation shall include Victoria Park that was first established as a market place in 1850 and continues to be one of the most important cultural community gathering locations, hosting farmers' markets as well as the weekly summer Pipe Band Parade.

The designation shall also include specific components of the yellow brick building, the former Town Hall, which was built in 1872. It served as the centre for local political decisions for the former Town of Kincardine for over 100 years and the auditorium was the Town's cultural centre.

Please be advised that the Description of Property and Statement of Cultural Heritage Value or Interest for 707 Queen Street (Victoria Park and Kincardine Centre for the Arts) may be reviewed on the Municipal website at [www.kincardine.net](http://www.kincardine.net) or at the Clerk's Department during regular business hours between 8:30 a.m. and 4:30 p.m. from Monday to Friday.

AND TAKE NOTICE THAT any person who objects to this proposed repeal and/or designation shall, within thirty days after the date of the publication of the notice of intention (July 25, 2012), serve on the Clerk of the Municipality, at the address noted in banner, a notice of objection setting out the reasons for the objection and all relevant facts.
