THE CORPORATION OF THE TOWN OF DUNDAS

BY-LAW NO. 3899-90

A BY-LAW OF THE CORPORATION OF THE
TOWN OF DUNDAS, BEING A BY-LAW TO
DESIGNATE A PORTION OF THE TOWN AS
A HERITAGE CONSERVATION DISTRICT

WHEREAS subsections 41(1) and 41(3) of the The Ontario Heritage
Act, R.S.O., 1980, Chapter 337 provide as follows:

"41. (1) Subject to subsection (2), where
there is in effect in a municipality an
official plan that contains provisions relating
to the establishment of heritage conservation
districts, the council of the municipality may
by by-law designate the municipality or any
defined area or areas thereof as a heritage
conservation district."

"41. (3) A by-law passed under subsection (1)
does not come into force without the approval
of the Board."

AND WHEREAS The Council of the Corporation of the Town of Dundas
directed a study be undertaken for the study area shown on Schedule "C" hereto
attached as a potential Heritage Conservation District for future designation;
AND WHEREAS such study has been completed;

AND WHEREAS the Official Plan of the Town of Dundas contains provisions relating to the establishment of heritage conservation districts;

AND WHEREAS it is intended to designate an area identified by the said study;

AND WHEREAS this Council is empowered under Subsection 6 of Section 31 of the Ontario Heritage Act, R.S.O. 1980, Chapter 337, as amended, to enact by-laws to repeal by-laws designating property, including exteriors of buildings to be of historic or architectural value or interest;

AND WHEREAS this Council has caused to be served upon the owners of the properties known municipally as 31-33 Melville Street, 41-43 Cross Street, 32 Cross Street and 42 Melville Street, in the Town of Dundas and upon the Ontario Heritage Foundation notice of intention to so dedesignate the said properties and has caused such notice of intention to be published in a newspaper having a general circulation in this Municipality, once for each of three consecutive weeks;

AND WHEREAS no notice of objection to the proposed dedesignation of the said property has been served on the Clerk of this municipality within the time prescribed by the said statute;

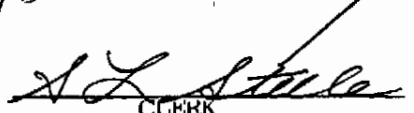
NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF
DUNDAS ENACTS AS FOLLOWS:

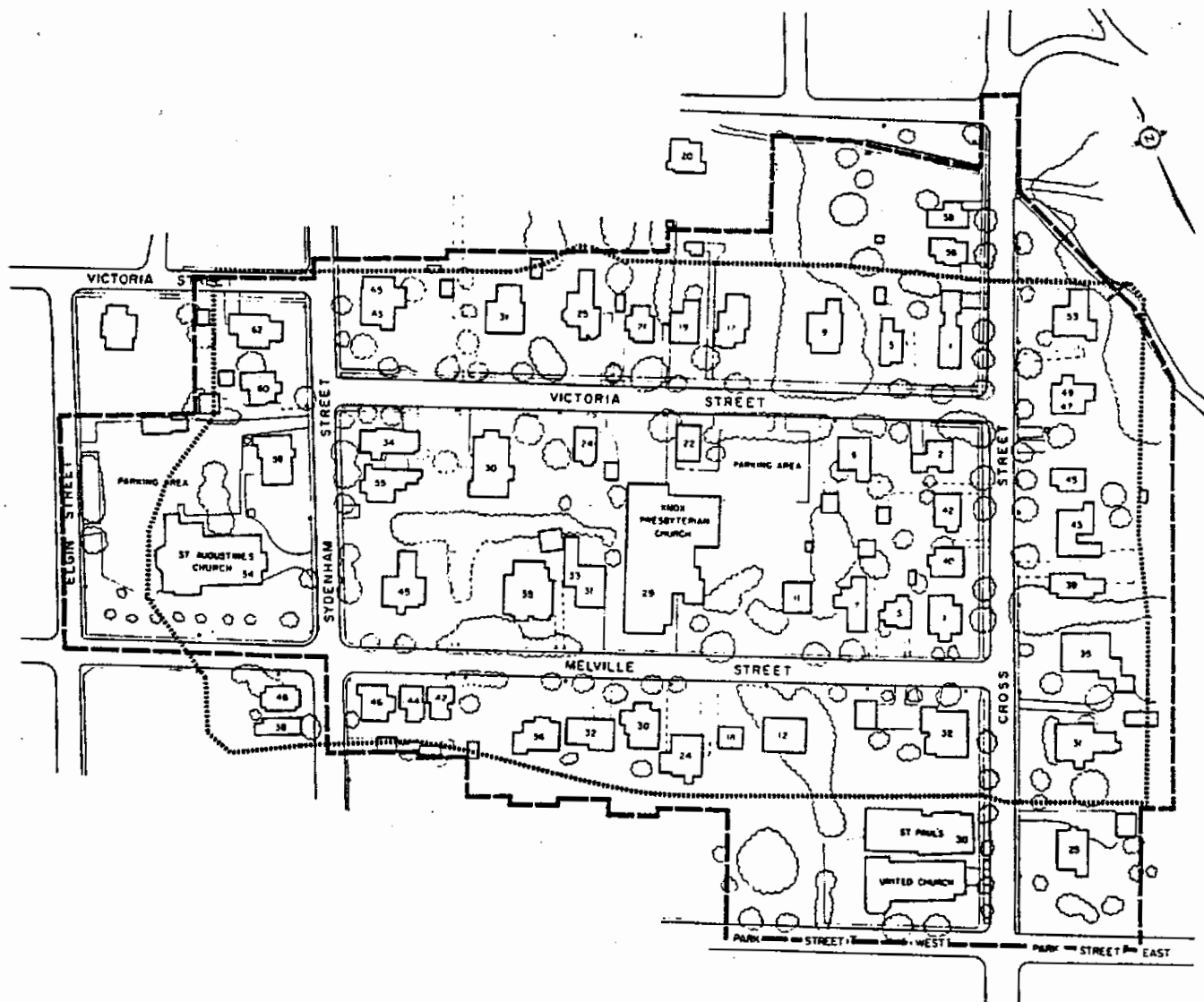
1. The area shown as "Heritage Conservation District" on Schedule "C" hereto annexed and forming part of this By-law is hereby designated as a Heritage Conservation District.
2. By-law No. 3090-79 designating 31-33 Melville Street and By-law No. 3235-81 designating 41-43 Cross Street as buildings of historical and architectural value pursuant to the Ontario Heritage Act be and the same are hereby repealed.
3. By-law No. 3458-84 designating 32 Cross Street, 42 Melville Street, 200 Hatt Street, 60 Melville Street, 24 Napier Street North, 31 Napier Street North, 25-27 Sydenham Street and 31 Sydenham Street as historic or architectural value or interest be amended as follows:
 - (a) By deleting the words "32 Cross Street" and "42 Melville Street" in the title of By-law No. 3458-84, in Paragraph 2 of the preamble to By-law No. 3458-84 and in Section 1 of By-law No. 3458-84;

- (b) By deleting all references to 32 Cross Street and 42 Melville Street in Schedule "A" and Schedule "B" attached to and forming part of By-law No. 3458-84.

4. This By-law takes effect on the issue by the Board of its order.

READ a First, Second and Third time and finally PASSED this Seventeenth day of September, A.D., 1990.
