Take notice that the Council of the Corporation of the City of Stratford, at a meeting held on March 12, 2001 has designated the property at the following municipal address as a property of architectural and historical value or interest under Section 29, of the Ontario Heritage Act, R.S.O. 1990, Chapter 0.18.

111 Water Street - Reasons for Designation

This Edwardian Classicism house was built in 1902. The reasons for designation are the original "fishscale" shingling at the upper front gable. The shingling displays a sun ray pattern with related decorative woodwork.

The building's most distinctive feature is the bandstand style porch, with its steep conical and circular shaped roof. There is stained glass at the attic window and the first floor windows have the original storms. The decorative main entrance door is original and has a transom window.

An interior feature included in the reasons for designation are square tapered wood columns and associated millwork that flank the entrance to a smaller room off of the parlour.

The general exterior components of the building that are designated are the brickwork, remaining wood eaves for both the porch and main structure, remaining original windows and storms, front entrance door and transom with casing. Components found in the upper front gable are also designated and include fish-scale shingling, sunray decorative piece, decorated fascia, and stained glass attic window.

More specifically, primary components of the bandstand style porch are designated including the form of the porch itself (the circular end form and the conical shaped roof capping this form), all columns, posts, and rails, tongue and groove floor planking, BC fir porch ceiling, porch apron and steps.

Finally, an interior room divider (located between the current dining and sitting room to east) is designated including the square-tapered columns and associated woodwork.



BY-LAW NUMBER 34-2001 OF THE CORPORATION OF THE CITY OF STRATFORD

BEING a by-law to designate the real property known municipally as 111 Water Street, Stratford as being of architectural and historical value or interest.

WHEREAS Section 29 of the *Ontario Heritage Act, R.S.O. 1990, Chapter O.18* authorizes the Council of a municipality to enact by-laws to designate real property including all buildings and structures thereon, to be of architectural and historical value or interest;

AND WHEREAS the Council of The Corporation of the City of Stratford has consulted with its Local Architectural Conservation Advisory Committee;

AND WHEREAS the Council of The Corporation of the City of Stratford has caused to be served upon The Ontario Heritage Foundation and the owners of the property known as 111 Water Street, Stratford, notice of its intention to so designate the aforesaid real property and has caused general circulation in the City of Stratford by publication of the notice of intention in a newspaper having general circulation in the municipality;

AND WHEREAS no written notice of objection to the proposed designation has been served on the Clerk of the Municipality within the prescribed time.

NOW THEREFORE BE IT ENACTED by Council of The Corporation of the City of Stratford as follows:

- 1. That the real property known as 111 Water Street, in the City of Stratford is hereby designated as being of architectural and historical value or interest for the reasons described in Schedule "A" attached hereto.
- 2. The Municipal Solicitor is hereby authorized to cause a copy of this by-law to be registered in the proper land registry office against the property described in Schedule "B" attached hereto.
- 3. The Clerk is hereby authorized to cause a copy of this by-law to be served on The Ontario Heritage Foundation and the owner of the property and to cause notice of the passing of this by-law to be published in the Stratford Beacon Herald being a paper having a general circulation in the municipality.
