## NOTICE OF INTENTION TO DESIGNATE A BUILDING OF CULTURAL HERITAGE VALUE OR INTEREST

TAKE NOTICE THAT the Council of The Corporation of the Town of Aurora intends to designate the following property as a property of Cultural Heritage Value or Interest pursuant to the provisions of Section 29 of the *Ontario Heritage Act*, R.S.O. 1990, Chapter O.18, as amended. A brief statement of reasons is included.

15218-15220 Yonge Street
The Clift Block
Part of Lot 14, W/S Yonge Street, Plan 9 as in R366174, except easements therein, Town of Aurora, Regional Municipality of York, being all of PIN 03652-0050 (LT)

## **Description of Property**

The property known municipally as 15218-15220 Yonge Street contains a 2 storey brick commercial building designed in an Italianate architectural style located in the heart of Aurora's historic downtown on the west side Yonge Street.

Statement of Cultural Heritage Value or Interest

In 1887, a fire destroyed many commercial structures on the west side of Yonge Street. After the fire, the Clift Block was built in conjunction with the Odd Fellows and Andrews Block to the south. The building was constructed in 1887 for William B. Clift, a grocer who also sold china and other goods. During its history the building contained a number of long-standing commercial businesses, including the Aurora Banner who occupied the northern section of the building for over sixty-five years and a series of jewelers who occupied the southern section of the building for over ninety years. In recent years, the northern section of the building has operated as a law office and the southern section was used as a restaurant.

## Description of Heritage Attributes

Important to the preservation of the property are the original key attributes that express its value, which include:

## **Exterior Elements**

- 1880's style flat roof and brick work
- extended parapet is placed above the middle third of the front elevation;
- · two brick pilasters which evenly divide the second floor into three sections;
- fenestration on the front elevation features three window openings, each capped with a brick voussoir and evenly spaced between the brick column partitions;
- rear elevation features a brick façade with original window and cellar openings.

DETAILED REASONS FOR THE PROPOSED DESIGNATION CAN BE OBTAINED BY CONTACTING THE UNDERSIGNED.

Pursuant to Section 29(5) of the *Ontario Heritage Act*, any person may, before 4:30 p.m. on the **10<sup>th</sup> day of September 2018**, (within 30 days of the publication of this notice) send by registered mail or deliver to the Town Clerk, Notice of Objection to the proposed designation, together with a statement setting out the reasons for the objection and all relevant facts. If a Notice of Objection is received, the Council of the Town of Aurora will refer the matter to the Conservation Review Board for a hearing and a report.

Further information respecting the proposed designation is available from the Town Clerk's Office upon request.
