



Dear property owners,

As the owners of a property currently undergoing alterations to provide accessibility, I am writing to advise you of your obligation to complete a 'Proposed Alteration to a Designated Heritage Building Application' before proceeding with any changes or alterations to the building's heritage features. I have enclosed a copy of the application for your convenience.

After reviewing the report by the Ontario Heritage Trust, we can advise that the Heritage Preservation Office of the City of Peterborough will not approve the replacement or alteration the windows of the Parish Hall, as they are not beyond repair and are part of the historic fabric and one of the character defining elements of the building. We would be happy to provide you with more information on maintaining and repairing historic windows.

With respect to the vestibule being constructed on the 1957 addition, we realize that this portion of the building is not part of the original historical fabric of the Church nor is it included in the designation by-law, but it is an integral part of the building's overall character and we do expect that the vestibule be constructed in a sympathetic manner to its modernist design.
