BY-LAW NO. 93-91 (HO-1)

BEING A BY-LAW TO REPEAL BY-LAW NUMBER 92-54 (H0-1) BEING A BY-LAW TO DESIGNATE A MUNICIPAL RESIDENCE IN THE TOWN OF GEORGINA AND/OR BUILDING OF HISTORIC AND ARCHITECTURAL SIGNIFICANCE.

WHEREAS the Council on 9th day of April, 1992, pursuant to Section 29 (6) of the Ontario Heritage Act designated the dwelling located at 80 High Street, Village of Sutton, Block 12, Lot 2, Plan 69, as being of historical/architectural value or interest.

AND WHEREAS the Local Architectural Conservation Advisory Committee have recommended that Council repeal the said hy-law.

NOW THEREFORE the Council of The Corporation of the Town of Georgina enacts as follows:

- 1. That By-Law 92-54 ((HO-1) being a by-law designating the dwelling located at 80 High Street, Village of Sutton, described as Block 12, Lot 2, Plan 69, to be of architectural/historical value and/or interest, more particularly described in Schedule "A" attached hereto is HEREBY REPEALED.
- 2. The Clerk is hereby authorized and directed to cause a copy of this by-law to be registered against the property described in Schedule "A" attached hereto in the Land Registry Office.
- 3. The Clerk is hereby authorized and directed to cause a copy of this by-law to be served upon the Owner of the property and upon the Ontario Heritage Foundation and to cause a notice of this by-law to be published for three consecutive weeks in a newspaper having general circulation in the Town of Georgina.

READ a First and Second time this 8th day of July, 1993.

READ a Third time and finally passed this 8th day of July, 1993.
