BY-LAW

Number 221-2002

A by-law to amend the boundary of the Village of Churchville Heritage Conservation District

WHEREAS Section 41 of the Ontario Heritage Act, (R.S.O. 1990, c.O. 18 as amended) authorizes the Council of a municipality to designate by by-law an area as a Heritage Conservation District where there is in effect in a municipality an Official Plan that contains provisions relating to the establishment of Heritage Conservation Districts;

AND WHEREAS Section 4.9.3 of Part I of the Official Plan (1993) of the City of Brampton contains provisions relating to the establishment of Heritage Conservation Districts, in accordance with the requirements of Section 41(1) of the said Act;

AND WHEREAS Sections 3.1.24 and 5.3.5 of Part II, Chapter 40(a) of the 1993 Official Plan (Bram West Secondary Plan) state that the boundaries of the Churchville Heritage Conservation District will be amended to exclude lands that will accommodate development adjacent to the Village proper;

AND WHEREAS the Council of the City of Brampton maintains its previous adoption by by-law 218-90 of the "Churchville Heritage Conservation District Plan";

NOW THEREFORE the Council of the Corporation of the City of Brampton hereby amends by-law number 219-90 to amend the current area of the "Churchville Heritage Conservation District" by deleting schedule 'A' thereto and substituting therefore Schedule 'A' to this amendment.

This by-law will not come into force until approved by the Ontario Municipal Board:

READ a FIRST, SECOND, and THIRD TIME and PASSED in Open Council, this 14th day of August, 2002






