NOTICE OF THE PASSING OF BY-LAW NO. 14-86 (Under the Ontario Heritage Act, R.S.O. 1990, cO.18)

TAKE NOTICE that on September 16, 2014 the Council of the Town of Mississippi Mills passed By-law No. 14-86 which designates the downtown Almonte Heritage Conservation Study Area under Part V of the Ontario Heritage Act.

AND TAKE NOTICE that any person or organization may appeal to the Ontario Municipal Board (OMB) by filing with the Town Clerk of the Town of Mississippi Mills, Ms. Julie Oram no later than 4:30 p.m. on Monday, November 3, 2014 a notice of appeal. The Notice of Appeal must set out the objection to the by-law and the reasons in support of the objection and be accompanied by the \$125.00 fee prescribed under the Ontario Municipal Board Act in the form of a certified cheque or money order payable to the Minister of Finance.

The purpose of this by-law is to prohibit or set limitations on any alterations, erections, demolitions or removals of buildings or structures within the proposed heritage study area for up to one year. The downtown Almonte Heritage Conservation Study Area is outlined in red as shown on Schedule 'A' in the by-law.

A copy of By-law No. 14-86 is enclosed.

BY-LAW NO. 14-86

BEING a by-law to designate downtown Almonte and surrounding area as a heritage conservation district study area.

WHEREAS Section 40.1 (1) of the Ontario Heritage Act permits a municipality to designate a heritage conservation district study areas for a period of up to one year;

AND WHEREAS Section 40.1 (2) of the Ontario Heritage Act permits the municipality to prohibit or set limitations with respect to the alteration, erection or demolition of property situated in the heritage conservation district study area;

AND WHEREAS the properties located within downtown Almonte and surrounding area includes a concentration of buildings and landscape elements which may have cultural heritage significance;

AND WHEREAS at its meeting held on October 1, 2013, the Council of the Corporation of the Town of Mississippi Mills passed Resolution No. 362-13 to approve the Request for Proposal including the Scope of Work for the downtown Almonte and surrounding area Heritage Conservation District Study and Plan under Part V of the Ontario Heritage Act, R.S.O., 1990, c.O.18, as amended;

AND WHEREAS Council retained the services of Watson MacEwen Teramura Architects to undertake the Heritage Conservation District study and plan for this area in December, 2013;

AND WHEREAS the purpose of a heritage conservation district study is to examine the character of an area to determine if the area should be designated as a heritage conservation district, what the appropriate area should be and to develop guidelines to manage change to properties located within the district;

AND WHEREAS the Council of the Corporation of the Town of Mississippi Mills deems it desirable to prohibit or set limitations within the study area until such time as the study and guidelines are completed;

NOW THEREFORE the Council of the Corporation of the Town of Mississippi Mills enacts as follows:

- 1. The area shown outlined in bold, attached hereto as Schedule 'A' and listed by the municipal addresses by which the real property is known municipally on the attached Schedule 'B' is hereby designated as a heritage conservation district study area for a period of up to one (1) year.
- 2. The Town of Mississippi Mills shall undertake a heritage conservation district study in the heritage conservation district study area in accordance with the requirements of the Ontario Heritage Act for the purpose of examining the character of the area to determine if the area, or any part thereof, should be preserved as a heritage conservation district and to make recommendations with respect to the content of a heritage conservation district plan.

- 3. During a period of up to one year from the date of enactment of this by-law, the following works are deemed minor alterations that do not require approval from either the Town's Heritage Committee or Council:
 - a. Interior alterations
 - b. Painting / paint colour using a similar colour to the existing
 - c. Regular on-going building maintenance such as repointing and foundation repairs
 - d. Repair or restoration, using the same materials, of existing features including roofs, exterior cladding, cornices, brackets, columns, balustrades, porches and steps, entrances, windows, foundations and decorative wood, metal or stone.
 - e. Alterations to soft landscaping such as garden beds;
 - f. Minor exterior alterations, demolitions or additions related to life safety as determined by the municipality.
- 4. During a period of up to one year from the date of enactment of this by-law, the following works shall not be permitted as follows:
 - a. any alterations to a property other than those identified in 3. above;
 - b. the erection, demolition or removal of buildings or structures
- 5. Notwithstanding 4. above, properties designated under Part IV, Section 29 of the Ontario Heritage Act may apply for permission to alter their properties consistent with Section 33 of the Ontario Heritage Act.
- 6. The Town Clerk is hereby authorized to cause notice of the passage of this By-law to be served upon the owners of property described in Schedule 'A', the Ontario Heritage Trust and to cause the notice of the passage of this By-law to be published in a newspaper having general circulation in the Town of Mississippi Mills.
- 7. The schedule attached hereto and marked Schedule 'A' forms part of this by-law and all notations, references and other information contained herein shall be as much a part of this by-law as if all matters and information set forth by the set Schedule were all fully described herein.
- 8. This by-law comes into force and effect upon the day of its passing.


