NOTICE OF PASSING OF A BY-LAW TO DESIGNATE THE PICTON MAIN STREET HERITAGE CONSERVATION DISTRICT AND ADOPT THE PICTON MAIN STREET HERITAGE CONSERVATION DISTRICT PLAN

TAKE NOTICE THAT the Council of the Corporation of the County of Prince Edward passed **By-law No. 3286-2013** on **July 23, 2013** under Section 41 of the Ontario Heritage Act, R.S.O. 1990, as amended.

AND TAKE NOTICE THAT any person or public body may appeal to the Ontario Municipal Board in respect to the By-law by filing with the Clerk of the Corporation of the County of Prince Edward no later than 4:30 p.m. on the 9th day of September, 2013 a notice of appeal setting out the objection to the By-Law and the reasons for the appeal, accompanied by the prescribed appeal fee(s), made payable to the Minister of Finance in the amount of \$125.00. If you wish to appeal to the OMB, a copy of an appeal form is available from the OMB website at www.omb.gov.on.ca.

Only individuals, corporations and public bodies may appeal a by-law to the Ontario Municipal Board (OMB). A notice of appeal may not be filed by an unincorporated association or group. However, a notice of appeal may be filed in the name of an individual who is a member of the association or the group on its behalf.

No person or public body shall be added as a party to the hearing of the appeal unless, before the by-law was passed, the person or public body made oral submissions at a public meeting or written submissions to the council or, in the opinion of the Ontario Municipal Board, there are reasonable grounds to add the person or public body as a party.

Purpose and Effect of the By-law:

The purpose and effect of the By-Law is to adopt the "Picton Main Street Heritage Conservation District Plan" dated June 13, 2013 and to designate the portion of Picton Main Street identified on the attached map as a Heritage Conservation District pursuant to Part V of the Ontario Heritage Act, R.S.O. 1990, as amended.
