BY-LAW NO. 2007-172

A By-law to define an area of the City of St. Catharines to be examined for future designation as a heritage conservation district.

WHEREAS Council has consulted with The Corporation of the City of St. Catharines's Municipal Heritage Committee (St. Catharines Heritage Committee) as required by the Ontario Heritage Act, R.S.O. 1990, c. O.18, as amended, and has determined to study the area subject to this By-law, for possible future designation under The Ontario Heritage Act.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF ST. CATHARINES enacts as follows:



Read a third time and passed this 4th day of June 2007.


