



**BY-LAW NO. 2003-350**

**A BY-LAW TO AMEND BY-LAW NO. 3-84 (FORMER PITTSBURGH TOWNSHIP) "A BY-LAW TO DESIGNATE CERTAIN PROPERTIES AS PROPERTIES OF HISTORIC AND ARCHITECTURAL VALUE OR INTEREST" (De-Designation Of Vacant Lands At ~~24~~ Faircrest Boulevard)**

**PASSED:** August 12, 2003

**WHEREAS** the Owner of a property designated under the Ontario Heritage Act R.S.O. 1990, Ch. 0.18 has applied to Council to amend part of By-Law No. 3-84 "A By-Law To Designate Certain Properties As Properties Of Historic And Architectural Value Or Interest", in order to de-designate vacant lands on the property known as Civic Number 24 Faircrest Boulevard.

**AND WHEREAS** Council has consulted with its Municipal Heritage Committee and has approved the application.


**AND WHEREAS** Notice of the repealing by-law was published in a newspaper having general circulation in the municipality on August 6, 2003.


**NOW THEREFORE** the Council of the Corporation of the City of Kingston hereby enacts as follows:

1. By-Law No. 3-84 (Former Pittsburgh Township) entitled "A By-Law To Designate Certain Properties As Properties Of Historic And Architectural Value Or Interest" is hereby amended as follows:
  - 1.1. Section 1, Subsection (d) is hereby amended by adding the following new subsection (i) thereto as follows:
    - 1.(d) (i) Notwithstanding the designation described in Subsection (d), Section 1. of this By-Law, the property described as Part of Lot 1, Concession 1, City of Kingston, Geographic Township of Pittsburgh, County of Frontenac, designated as Part 3 on Reference Plan 13R-16806 is hereby de-designated as being of historical value or interest"
2. A copy of the repealing by-law to be registered against the property affected in the proper land registry office.
3. This By-Law shall come into force and take effect on the date of its passing.
