TAKE NOTICE that the Corporation of the Town of Brighton has received a request, and intends to designate the above property at 60 Maplewood Ave., better known as Memory Junction, as a Heritage Property under Part IV of the Ontario Heritage Act. The By-Law may be passed during the regular Council meeting on August 16, 2000.

The site is being designated because it is the location of the Grand Trunk Railway (GTR) Station which was built in the 1850's. During the 19th century the railway station played an important role in the growth of the surrounding community. The train station has continued to be a symbol to the community and its ties to the railway. This building is the only brick GTR railway station of the original thirty-four (34) built, and one of the approximately nine (9) remaining GTR stations in the province. It is a type C Station. The following is a list of architectural features: the basic structure of the building, brick exterior, semi-circular arched voussoirs over the original openings, and forming complete circles around the bulls-eye ventilators, triangular brackets carrying the projecting eaves, exposed rafters on the gable ends, arched transoms, interior room design, trim within Operators Bay, and the wall and ceiling cornices, circular mouldings, and wainscot in the Freight Room. Additional information relating to the proposed Heritage Designation is available for public inspection during regular business hours at the Planning Department, Brighton Municipal Centre, 35 Alice Street, Brighton.

Any person may object to this designation by submitting a notice of objection to the Clerk of the Town of Brighton on or before Friday August 4, 2000. Notice of Objection must state the reasons for the objection and all relevant facts.
