



OF THE CORPORATION OF THE CITY OF STRATFORD

BEING a by-law to designate 105 Water Street under Part IV of the Ontario Heritage Act as being of architectural and historical value or interest.

WHEREAS Section 29 of the Ontario Heritage Act, R.S.O. 1990, Chapter O.18 authorizes the Council of a municipality to enact by-laws to designate real property including all buildings and structures thereon, to be of architectural and historical value or interest;

AND WHEREAS the Council of The Corporation of the City of Stratford has consulted with its Municipal Heritage Committee;

AND WHEREAS the Council of The Corporation of the City of Stratford has caused to be served upon The Ontario Heritage Foundation and the owners of the property known as 105 Water Street, Stratford, notice of its intention to so designate the aforesaid real property and has caused general circulation in the City of Stratford by publication of the notice of intention in a newspaper having general circulation in the municipality;

AND WHEREAS no written notice of objection to the proposed designation has been served on the Clerk of the Municipality within the prescribed time.

NOW THEREFORE BE IT ENACTED by Council of The Corporation of the City of Stratford as follows:

- That the real property known as 105 Water Street, in the City of Stratford is hereby 1. designated as being of architectural and historical value or interest for the reasons described in Schedule "A" attached hereto.
- 2. The Municipal Solicitor is hereby authorized to cause a copy of this by-law to be registered in the proper land registry office against the property described in Schedule "B" attached hereto.
- 5. The Clerk is hereby authorized to cause a copy of this by-law to be served on The Ontario Heritage Foundation and the owner of the property and to cause notice of the passing of this by-law to be published in the Stratford Beacon Herald being a newspaper having general circulation in the municipality.

Reasons for the heritage designation of 105 Water Street:

ARCHITECTURAL DETAILS:

Edwardian Classicism Style, similar to 111 Water Street, which is already a designated house; Edwardian Classicism has balanced facades, simplified but large roofs, smooth brick surfaces and generous fenestration. It was an attempt to restore simplicity and order to domestic architecture in contrast to the earlier Queen Anne Style. House contributes significantly to an early 1900 streetscape; unusual angled front door; functional design of building excellent; intact pine sills (underneath current metal covers), on windows; building in an excellent state of repair; integrity of the historical relationship between the building and its associated landscape largely unchanged; building a conspicuous landmark in the neighbourhood; a very good example of the change in architectural taste at the turn of the twentieth century; building has good, solid proportions and is well-situated on the property enhancing the streetscape; original yellow brick quoins; original fish-scale shingling still exists under current siding in gable north side; linen cupboards built into knee walls throughout the house.

Exterior Elements Worthy Of Designation:

All brickwork; any original windows, sills and storm windows; unusual angled front door, north side; fish-scale shingling which is under current siding; balanced facades; simplified, large roofs; smooth brick surfaces on all facades; returns on gables; voussoirs over windows; all stone quoins.

Interior Elements Worthy Of Designation:

Linen cupboards built into knee walls throughout the house.

HISTORY OF HOUSE

- building erected 1905

- built for John B. Gillaland (bookkeeper, Borland Carriage Co.)

OWNERS OF THE HOUSE

Although John Gillaland caused the house to be erected. He was in residence only from 1905-1907. Directory records indicate that he was not resident in Stratford after 1907.

Emily and Frances Garden resided in the house the longest. Emily lived in the house from 1910-1939. Frances lived in the house from 1910-1953. Since they lived in the house so long their residency, in all likelihood, would have made their house a notable feature of the neighbourhood.

Emily Garden taught in Stratford schools for 40 years. She was a valued teacher in Stratford public schools. Eventually, she was appointed principal of Falstaff school and held this job until her retirement in 1922. She was associated with the work of the Women Teachers' Federation for many years. She died in 1940.

Frances Garden was also a teacher, at Shakespeare and Romeo elementary schools, for many years. She died in 1954, at the age of 84.
