ONTARIO HERITAGE TRUST REPORTS TO STORY REPORT TO STORY REPORT TO STORY ONTARIO HERITAGE TRUST **BY-LAW NUMBER 195-2006** OF THE CORPORATION OF THE CITY OF STRATFORD

BEING a by-law to designate 224 Wellington Street under Part IV of the Ontario Heritage Act as being of architectural and historical value or interest.

WHEREAS Section 29 of the Ontario Heritage Act, R.S.O. 1990, Chapter O.18 authorizes the Council of a municipality to enact by-laws to designate real property including all buildings and structures thereon, to be of architectural and historical value or interest;

AND WHEREAS the Council of The Corporation of the City of Stratford has consulted with its Municipal Heritage Committee;

AND WHEREAS the Council of The Corporation of the City of Stratford has caused to be served upon The Ontario Heritage Foundation and the owners of the property known as 224 Wellington Street, Stratford, notice of its intention to so designate the aforesaid real property and has caused general circulation in the City of Stratford by publication of the notice of intention in a newspaper having general circulation in the municipality;

AND WHEREAS no written notice of objection to the proposed designation has been served on the Clerk of the Municipality within the prescribed time.

NOW THEREFORE BE IT ENACTED by Council of The Corporation of the City of Stratford as follows:

- 1. That the real property known as 224 Wellington Street, in the City of Stratford is hereby designated as being of architectural and historical value or interest for the reasons described in Schedule "A" attached hereto.
- 2. The Municipal Solicitor is hereby authorized to cause a copy of this by-law to be registered in the proper land registry office against the property described in Schedule "B" attached hereto.
- 6. The Clerk is hereby authorized to cause a copy of this by-law to be served on The Ontario Heritage Foundation and the owner of the property and to cause notice of the passing of this by-law to be published in the Stratford Beacon Herald being a newspaper having general disculation in the municipality.

Reasons for the heritage designation of 224 Wellington Street:

ARCHITECTURAL DETAILS:

Ontario Cottage; largely unchanged, very good example of style in comparison with other buildings of same style that have been designated; visual quality of building (proportion, scale, detail), in the context of its architectural style excellent; functional quality (effectiveness of materials, layout and method of construction), excellent; quality of workmanship and handling of materials excellent; building compatible with present character of area with which it is associated; an excellent, well-preserved example of early Stratford domestic architecture; an established building in an older neighbourhood; a familiar landmark in the neighbourhood; elements of building very well integrated; ruby glass transom over door east side original.

Exterior Details Worthy Of Designation:

Ruby glass transom entrance east side; iron cresting at peak of roof; round-top wooden shutter gable east side; all original brickwork; all original fieldstone foundation; all original quoins.

HISTORY OF HOUSE

Ontario Cottage with many original features and some changes; has a connection with the early railway history of Stratford; built in 1887 for John Edwards, a boilermaker for the Grand Trunk Railway; John Edwards lived in the house until 1905; in 1913 house purchased by Neil Dow; James Dow, a blacksmith (son of Neil) and/or his wife, Minnie, lived in house until 1965.
