### NOTICE OF INTENTION TO REPEAL BY-LAW DESIGNATING PROPERTY

**TAKE NOTICE** that the Council of the Corporation of the Town of St. Marys intends to repeal By-law Number 31 of 1978, "Being a by-law to designate the property known municipally as the Queen Street Bridge crossing the Thames River and the Mill Race from Trout Creek on the north, under the small arch of the Bridge to the point where the water re-enters the Thames River south of the Bridge", under Section 31 of the Ontario Heritage Act, R.S.O. 1980.

**DESCRIPTION OF THE PROPERTY** Queen Street Bridge (also known as Victoria Bridge) which crosses the Thames River and the Mill Race from Trout Creek on the north, passing under the small arch of the Bridge to the point where the water re-enters the Thames River to the south of the Bridge.

**REASON FOR THE PROPOSED REPEALING BY-LAW** St. Marys Town Council has voted to replace the Queen Street Bridge (Victoria Bridge) rather than restore it. Construction of the new bridge will involve part of the Mill Race.

Notice of objection to the repealing by-law, together with a statement of the reasons for the objection and all relevant facts, may be served on the Clerk of the Town of St. Marys before the 11th day of February, 1983.
