159-161 Queen Street East - Town Hall Antiques


Reasons for Designation:

This two and a half storey building is one of the best preserved limestone commercial buildings in St. Marys and is also one of the earliest. Built certainly before 1859 of coursed rubble, the second storey windows, which are squared with stone lintels originally had six panes in each sash. The dormers are flanked by classicizing, flattened pilasters.

This building is one of only a handful of limestone buildings in St. Marys that is still almost perfectly preserved and should definitely be protected by designation.

Notice Of Intention To Designate

TAKE NOTICE that the Council of the Corporation of the Town of St. Marys intends to designate the property, including lands and buildings, at the following municipal address as a property of architectural value or interest under Part IV of the Ontario Heritage Act, 1974, S.O. Chapter 122.

Municipal Address: 159-161 Queen Street East Reasons For Designation:

This two-and-a-half storey building is one of the best preserved limestone commercial buildings in St. Marys and is also one of the earliest. Built of coursed rubble, St. Marys limestone certainly before 1859, the cast iron window supports, doors, and cornice of this building are all original. The second storey windows, which are squared with flat stone arches, originally had six panes in each sash. The dormers are flanked by classicizing, flattened pilasters.

This building is one of only a handful of limestone buildings. In St. Marys that is still almost perfectly preserved and should definitely be protected by designation.

Notice of objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts may be served on the Clerk of the Town of St. Marys before the 30th day of September, 1981.
