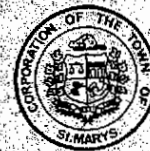

NOTICE OF INTENTION TO DESIGNATE A PLACE OF ARCHITECTURAL AND HISTORICAL VALUE

Notice is hereby given that the Council of the Separated Town of St. Marys intends to designate as a place of architectural and historical value the following property in accordance with the Ontario Heritage Act, Section 29, Part IV:

191 Widder Street East

(West half of Lots 10, 11 and 12, West side Peel Street North)

The house on this property was built in 1900 for David Maxwell Jr., a local industrialist, and is one of the finest examples in St. Marys of the Queen Anne style of architecture. Detailed reasons for designation of this property can be seen or obtained from the office of Bruce Grant, Chief Administrative Officer, Town of St. Marys, Box 998, St. Marys, ON N4X 1B6 during normal office hours (9 a.m. to 5 p.m. Monday to Friday.)

Any person who objects to this intended designation must within 30 days of the publication of this notice serve on the CAO a notice of objection in writing, setting out the reason for the objection and all relevant facts. The Ontario Heritage Act provides that where a notice of objection has been served, the Council shall refer the matter to the Conservation Review Board for a hearing.
