**CITY OF TORONTO**

**BY-LAW No. 436-2013**

**To amend By-law No. 1064-2009 designating the property at 166 Beaconsfield Avenue by replacing the sketch attached as Schedule "C".**

Whereas authority is given to the City Solicitor to make technical amendments to by-laws to correct technical errors; and

Whereas City Council passed By-law No. 1064-2009 to designate the property at 166 Beaconsfield Avenue (George Barrett House); and

Whereas as a result of a technical error, Sketch No. PS-2009-021 was attached as Schedule "C" rather than Sketch No PS-2009-079; and

Whereas it is necessary to correct this error and to replace Sketch No. PS-2009-021 with Sketch No. PS-2009-079;

The Council of the City of Toronto enacts:

1. By-law No. 1064-2009 is amended by deleting Schedule "C" and replacing it with the attached Schedule "C".
2. The City Solicitor is authorized to cause a copy of this by-law to be registered in the proper Land Registry Office against the property described in Schedule "A" to this by-law.
3. The City Clerk is authorized to cause a copy of this by-law to be served upon the owners of the property at 166 Beaconsfield Avenue and the Ontario Heritage Trust.


