**CITY OF TORONTO**

**BY-LAW 1404-2017**

**To make a technical amendment to correct the legal descriptions in Schedule B to By-law 1025-2017, designating the properties at 628 Church Street (Manhattan Apartments), and 634 and 636 Church Street (Bernard Haldan Houses), as being of cultural heritage value or interest.**

Whereas By-law 1025-2017 designating the properties at 628, 634 and 636 Church Street under Part IV of the *Ontario Heritage Act* as being of cultural heritage value or interest was enacted and passed by City Council on October 4, 2017; and

Whereas the legal description included in Schedule B for 634 Church Street was inadvertently also used to describe the properties and 628 and 636 Church Street; and

Whereas a technical amendment is required to correct the legal descriptions in Schedule B to By-law 1025-2017 to include the legal descriptions for 628 and 636 Church Street; and

Whereas under Section 169-26B of Municipal Code Chapter 169, Officials, City, the City Solicitor in consultation with the City Clerk, may submit bills directly to Council to make technical amendments to the Municipal Code and other by-laws to correct technical errors;

The Council of the City of Toronto enacts:

1. By-law 1025-2017 is amended by deleting the legal descriptions in Schedule B and substituting the legal descriptions contained in Schedule A attached to this by-law, as Schedule B to By-law 1025-2017.
2. The City Solicitor is authorized to cause a copy of By-law 1025-2017 as amended by this by-law, to be registered against the property described in Schedule A to this by-law, in the proper land registry office.
