Subject: Designations of 464 Locust Street, under the Ontario
Heritage Act, R.S.O. 1980, Chapter 337 as amended

The Council of the Corporation of the City of Burlington at its regular meeting held on Monday, April 22, 1985 enacted the resolution to designate 464 Locust Street, Burlington, Ontario as property having historical and architectural value and interest pursuant to the Ontario Heritage Act.

AND IN THE MATTER OF an intention by the Corporation of the City of Burlington to designate property known as municipal number 464 Locust Street, composed of Part of Lot 54, Registered Plan 74 in the City of Burlington, Regional Municipality of Halton.

NOTICE IS HEREBY GIVEN that the City of Burlington intends to designate the property known as 464 Locust Street composed of Part of Lot 54, according to William Bunton survey Registered Plan Number 74 registered in the Land Registry Office for the Registry Division of Halton (No. 20) as being historically and architecturally significant.

THE REASON FOR THE PROPOSED DESIGNATION is set out in Schedule "A" to this Notice.

ANY PERSON INTERESTED MAY within thirty (30) days after the date of first publication of this Notice, serve on the City Clerk of the City of Burlington a Notice of Objection setting out the reasons for the objection and all relevant facts.

ANY PERSON wishing to support the intention to designate may within thirty (30) days after the date of first publication of this Notice, serve on the Clerk of the City of Burlington a Notice of Support of the intention to designate together with a request for notice of any hearing that may be held giving also the name and address to which such notice should be sent.

SCHEDULE "A" TO NOTICE OF INTENTION TO DESIGNATE

REASONS FOR DESIGNATION

The house is one of Burlington's early brick structures from the Victorian era of architecture. The architectural 'fabric' of the facade maintains a consistent street elevation with earlier structures on Locust Street. The original brick residence was probably built by Richard Cole around 1896 on 2/5 of an acre of land purchased from the McCay family. Two later additions were probably constructed in 1918 and 1927 by a Mr. Redhead and Mr. Easton respectively. Later renovations were carried out in 1943 by the Bell-Chambers family.
