#### CITY OF NANTICOKE

BY-LAW NO. 40-88

Being a by-law to repeal the designation of property located at Lot 7 and Lot 16, Block 16, Plan 207, in the former Town of Port Dover, now in the City of Nanticoke in the Regional Municipality of Haldimand-Norfolk, as a property of historic and architectural value. (Powell-Sullivan Residence)

WHEREAS the <u>Ontario Heritage Act</u>, R.S.O. 1980, Chapter 337, as amended, provides for the conservation, protection and preservation of the heritage of Ontario, and provides that the council of a municipality may de-designate a property within the municipality at the request of the owner of the property;

AND WHEREAS the Council of The Corporation of the City of Nanticoke has received a request by the owners to de-designate the property located at Lot 7 and Lot 16, Block 16, Plan 207, in the former Town of Port Dover, now in the City of Nanticoke in the Regional Municipality of Haldimand-Norfolk;

AND WHEREAS the procedures required by Part IV of the <u>Ontario Heritage</u> <u>Act</u>, R.S.O. 1980, have been carried out and no Notice of Objection to the <u>Notice</u> of Intention to De-designate the aforementioned property was received;

NOW THEREFORE the Council of The Corporation of the City of Nanticoke hereby enacts as follows:

- 1. THAT the property known as the Powell-Sullivan Residence located at Lot 7 and Lot 16, Block 16, Plan 207, in the former Town of Port Dover, now in the City of Nanticoke in the Region of Haldimand-Norfolk, be hereby de-designated as property of historic and architectural value and interest for the purposes of the Ontario Heritage Act, R.S.O. 1980, Chapter 337.
- 2. THAT a copy of this By-law together with Schedule "A" attached hereto and forming part of this By-law, setting out the reasons for de-designation, shall be served upon the owner and the Ontario Heritage Foundation.

- 3. THAT a Notice of this By-law shall be published in a newspaper having general circulation in the City of Nanticoke.
- 4. THAT this By-law shall come into force and effect on the date of its final passing thereof and By-law No. 2-87 of the City of Nanticoke will be repealed.

## TO BY-LAW NO. 40-88

### **POWELL-SULLIVAN RESIDENCE**

REASONS FOR DE-DESIGNATION UNDER THE <u>ONTARIO HERITAGE ACT</u>, R.S.O. 1980, CHAPTER 337.

The property is located at Lot 7 and Lot 16, Block 16, Plan 207, in the former Town of Port Dover, now in the City of Nanticoke in the Regional Municipality of Haldimand-Norfolk. The Local Architectural Conservation Advisory Committee of the City of Nanticoke received a letter from the owners, dated December 28th, 1987, that requested that their home be de-designated under the Ontario Heritage Act. LACAC recommended to Council that this property be de-designated at their meeting of February 22, 1988. This recommendation was endorsed by City of Nanticoke Council at their meeting of March 1, 1988.
