BY-LAW 2016-032

**A BY-LAW TO DESIGNATE 57 ALBERT STREET NORTH, TOWN OF LINDSAY,
CITY OF KAWARTHA LAKES, AS BEING OF CULTURAL
HERITAGE VALUE AND INTEREST**

Recitals

1. Section 29 of the Ontario Heritage Act, R.S.O. 1990, provides that the Council of a municipality may pass a by-law designating a property within the boundaries of the municipality to be of cultural heritage value or interest.
2. Notice of Intention to Designate 57 Albert Street North, Town of Lindsay, City of Kawartha Lakes, described further in Schedule "A", has been given in accordance with Section 29 of the Ontario Heritage Act.
3. No objection to the proposed designation has been served on the Clerk of the City.
4. Reasons for Designation are set forth in Schedule "A".

Accordingly, the Council of The Corporation of the City of Kawartha Lakes enacts this By-law 2016-032.

Section 1.00: Definitions and Interpretation

1.01 Definitions: In this by-law,

"City", "City of Kawartha Lakes" or "Kawartha Lakes" means The Corporation of the City of Kawartha Lakes and includes its entire geographic area.

"City Clerk" means the person appointed by Council to carry out the duties of the clerk described in section 228 of the *Municipal Act, 2001*.

"Council" or "City Council" means the municipal council for the City.

"Director of Economic Development" means the person who holds that position and his or her delegate(s) or, in the event of organizational changes, another person designated by Council.

"Heritage Victoria" means the municipal heritage committee established by By-law 2007-219 pursuant to the Ontario Heritage Act.

"Foundation" means the Ontario Heritage Foundation

"Property" means property as set out in Section 2.01.

1.02 Interpretation Rules:

- (a) The Schedules attached to this by-law form part of the by-law, and are enforceable as such.
- (b) The words "include" and "including" are not to be read as limiting the meaning of a word or term to the phrases or descriptions that follow.

1.03 Statutes: References to laws in this by-law are meant to refer to the statutes, as amended from time to time, that are applicable within the Province of Ontario.

1.04 Severability: If a court or tribunal of competent jurisdiction declares any portion of this by-law to be illegal or unenforceable, that portion of this by-law shall be considered to be severed from the balance of the by-law, which shall continue to operate in full force and effect.

Section 2.00: Designation

- 2.01 57 Albert Street North, Town of Lindsay, City of Kawartha Lakes, is designated as being of historic interest and value, described further in Schedule "A". This designation shall not preclude any changes that may be deemed necessary for the efficient use of the building but that any and all such changes shall be in

keeping with the original and present character of the building and in consultation with the municipal heritage committee.

- 2.02 The City is hereby authorized to cause a copy of this by-law to be registered against the property described above in the proper Land Registry Office.
- 2.03 The Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation, and to cause notice of the passing of this by-law to be published in the newspaper.

| Section 3.00: Enforcement and Penalties |

- 3.01 **Enforcement**: This by-law may be enforced by every municipal law enforcement officer and police officer.
- 3.02 **Offence and Penalty**: It is an offence for a person to contravene any provision of this by-law, and every person who contravenes this by-law is guilty of an offence and, on conviction, is liable to a fine in accordance with the provisions of the *Provincial Offences Act* and to any other applicable penalty.

Description of Property

57 Albert Street North, Town of Lindsay, City of Kawartha Lakes

Legal Description:

PT LT 1 N/S WAVERLY ST PL 13 AS IN R335303; KAWARTHA LAKES

(PIN: 63224-0074(LT))

REASON FOR DESIGNATION

Architectural Design or Physical Value:

- The structure is representative of the American Federal period, also known as the Colonial Revival.

Historical Significance:

- The structure was constructed in 1933.
The structure reflects the work of John T. Hornsby, an architect from Peterborough, Ontario.
- The structure was the former home of Dr. H. D. Logan and son H. D. Logan Jr, Judge. H. D. Logan Sr. became mayor in 1937.
- The structure was featured in "Bless These Walls".

Contextual Value:

- The construction of the house created work during the depression.

ATTRIBUTES TO BE CONSERVED:

- The portico on front entrance
- Original Greek Revival dental work under the eavesdrop
- Brick exterior
- Eye brow / quarter moon windows on 3rd floor
