BY-LAW NO. 2015-126

**By-law to Repeal By-law 2007-60 being a By-law to Designate the Property at
1105 Front Road South and known as Patrick Laferte House**

WHEREAS the Council of the Corporation of the Town of Amherstburg approved By-law No. 2007-60 on the 10th day of September, 2007, said By-law being to designate the property at 1105 Front Road South, also known as Patrick Laferte House, as being of architectural and cultural value and interest.

AND WHEREAS the Council of the Corporation of the Town of Amherstburg passed a resolution on the 29th day of June, 2015 to approve the request for repeal by the homeowner.

AND WHEREAS pursuant to the provisions of the *Ontario Heritage Act, R.S.O 1990*, Section 32, there were no public appeals received by the Town of Amherstburg.

NOW THEREFORE the Council of the Corporation of the Town of Amherstburg hereby enacts as follows:

1. That By-law No. 2007-60 is hereby repealed in its entirety.
2. That this By-law shall come into effect on the day it is passed.

Read three times and finally passed this 23rd day of November, 2015.


