Please find enclosed the notice of the County of Brant's Councils intention to repeal the designating By-law 95-9G from the property located at 110 King Street, Burford Ontario, County of Brant. At the owners request, a motion to repeal the by-law was made at the November 7, 2019 Heritage Committee meeting and was passed by County of Brant Council at the December 17th meeting.

A notice of intent to repeal By-law 95-9G was advertised in the Brantford Expositor on December 19, 2019. The 30 day appeal period will end on January 17, 2020. If no appeals are received by the Clerk before this time a by-law will be presented at County of Brant's Council meeting on January 28, 2020.

The following is certified to be a true copy of a recommendation approved by the County of Brant Council at its meeting on December 17, 2019:

"Whereas By-law 95-9G, a By-law to Designate the Property known as 110 King Street, Burford, lacks detailed information with regards to elements of the house to be preserved;

And Whereas the owner is desirous of having the heritage designation removed from this property;

That staff be directed to first communicate Heritage Designation information with the owner;

That should the property owner provide a detailed written letter of direction formally acknowledging that the owner will assume associated costs, staff be directed to proceed with steps to remove the heritage designation on this property;

That the appropriate by-law, repealing By-law 95-9G be submitted for Council's consideration;

And that staff proceed with adding 110 King St. to the Heritage Registry".

At its meeting on December 17, 2019, County of Brant Council approved a resolution to remove the heritage designation of the home and structures located at 110 King Street, Burford. The repeal of the original heritage designation by-law (By-law 95-9G, as amended) will be considered by Brant County Council at its meeting on January 28, 2019.

The owner of the property has made application to County of Brant Council to repeal the designation of the home, site and structures as having historic and architectural significance.
