BY-LAW NO. 77-89

Being a By-law to designate the property located at Part Lot 13, Concession 3, in the geographic Township of Woodhouse, in the City of Nanticoke, in the Regional Municipality of Haldimand-Norfolk, being more particularly described in Schedule "A" to this by-law. (Shand-Hourigan Residence).

WHEREAS the <u>Ontario Heritage Act</u>, R.S.O. 1980, Chapter 337, as amended, provides for the conservation, protection and preservation of the heritage of Ontario, and provides that the Council of a municipality may designate a property within the municipality to be of historic and/or architectural value or interest;

AND WHEREAS the Council of The Corporation of the City of Nanticoke deems it desirable to designate the property located at Part Lot 13, Concession 3, in the geographic Township of Woodhouse, in the City of Nanticoke, in the Regional Municipality of Haldimand-Norfolk, being more particularly described in Schedule "A" to this by-law as a property of historic and architectural value and interest;

AND WHEREAS the procedure required by Part IV of the <u>Ontario</u> <u>Heritage Act</u>, R.S.O. 1980 have been carried out and no Notice of <u>Objection</u> to the <u>Notice</u> of <u>Intention</u> to <u>Designate</u> the aforementioned property was received;

 $\,$  NOW THEREFORE the Council of The Corporation of the City of Nanticoke hereby enacts as follows:

1. THAT the property known locally as the Shand-Hourigan Residence, located at Part Lot 13, Concession 3, in the geographic Township of Woodhouse, in the City of Nanticoke, in the Regional Municipality of Haldimand-Norfolk, being more particularly described in Schedule "A" to this by-law, be designated as a property of historic and architectural value and interest for the purposes of the Ontario Heritage Act, R.S.O. 1980, Chapter 337.

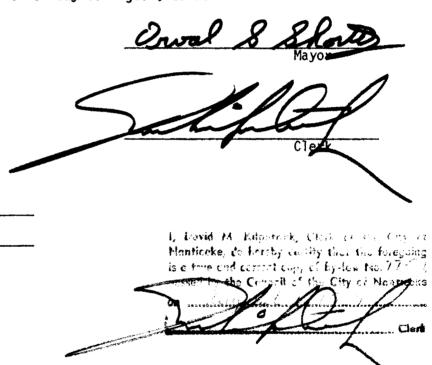

SHAND-HOURIGAN RESIDENCE

REASONS FOR DESIGNATION UNDER THE <u>ONTARIO HERITAGE ACT</u>, R.S.O. 1980, CHAPTER 337.

The Shand-Hourigan residence, located at part Lot 13, Concession 3, in the geographic Township of Woodhouse, in the City of Nanticoke, in the Regional Municipality of Haldimand-Norfolk, being more particularly described in Schedule "A" to this by-law, is a well preserved, two story brick building typical of the Bracketed or Italianate style of architecture. It is one of five houses constructed by Bob Paskins, all similar in exterior design but each with a different interior staircase.

The following exterior features are specifically noted for their architectural significance:

- The facade including the porch, doorway, windows, brackets and roofline.
- The south elevation of the main block and the kitchen extension including the verandah, doors, windows, and the roofline.
