Being a By-law to designate the property located at Part Lot 17, Concession 8, in the former Township of Townsend, now in the City of Nanticoke, in the Regional Municipality of Haldimand-Norfolk, being more particularly described in Instrument #458539 as registered in the Registry Office for the Registry Division of Norfolk (No. 37), as a property of historic and architectural value. (Slaght-Bramhill Residence).

WHEREAS the <u>Ontario Heritage Act</u>, R.S.O. 1980, Chapter 337, as amended, provides for the conservation, protection and preservation of the heritage of Ontario, and provides that the Council of a municipality may designate a property within the municipality to be of historic and/or architectural value or interest;

AND WHEREAS the Council of The Corporation of the City of Nanticoke deems it desirable to designate the property located at Part Lot 17, Concession 8, in the former Township of Townsend, now in the City of Nanticoke, in the Regional Municipality of Haldimand-Norfolk, being more particularly described in Instrument #458539, as registered in the Registry Office for the Registry Division of Norfolk, as being a property of historic and architectural value and interest;

AND WHEREAS the procedures required by Part IV of the <u>Ontario</u> <u>Heritage Act</u>, R.S.O. 1980 have been carried out and no Notice of <u>Objection</u> to the Notice of Intention to Designate the aforementioned property was received;

THE SLAGHT-BRAMHILL RESIDENCE

REASONS FOR DESIGNATION UNDER THE <u>ONTARIO HERITAGE ACT</u>, R.S.O. 1980, CHAPTER 337.

The Slaght-Bramhill residence located at Part Lot 17, Concession 8, in the former Township of Townsend, now in the City of Nanticoke, in the Regional Municipality of Haldimand-Norfolk, being more particularly described in Instrument #458539 as registered in the Registry Office for the Registry Division of Norfolk (No. 37), displays a simple Gothic style. This one and a half storey field stone structure attests to the geography of the land and the settlers use of available material on hand. The following features are specifically noted for there architectural significance:

Exterior - all stone elevations and foundation.
Interior - front west parlour, hall, staircase and dining room.
