Please find enclosed a notarized copy of By-law 006-20 which repeals By-law 95-9G on 110 King Street in Burford, Ontario. At the owners request, a motion to repeal the by-law was made at the November 7, 2019 Heritage Committee meeting and was passed by County of Brant Council at the December 17th meeting.

A notice of intent to repeal By-law 95-9G was advertised in the Brantford Expositor on December 19, 2019. The 30 day appeal period ended on January 17, 2020 with no appeals. The by-law was presented at County of Brant's Council meeting on January 28, 2020 and after which a notice of passing was advertised in the Brantford Expositor.

THE CORPORATION OF THE COUNTY OF BRANT

To repeal By-law Number 95-9G, a by-law to designate property known as 110 King Street Burford

WHEREAS a request was received from the owner of 110 King Street, Burford to have the heritage designation removed from this property;

AND WHEREAS the County of Brant Heritage Committee supported the removal of the designation and repeal of the designation by-law,

AND WHEREAS County of Brant Council approved the resolution to remove the designation;

AND WHEREAS notification requirements under the Ontario Heritage Act have been met and no appeals have been submitted;
