BY-LAW NUMBER 90-259

BEING A BY-LAW TO AMEND BY-LAW NUMBER 1983-51, ENTITLED 'A BY-LAW TO DESIGNATE CERTAIN PROPERTIES IN THE CITY OF PETERBOROUGH UNDER THE ONTARIO HERITAGE ACT, 1974' (THE JAMES BLACKWELL HOUSE, 1066 ARMOUR ROAD)

WHEREAS the Council of the City of Peterborough did on the 2nd day of May, 1983, enact By-law 1983-51 designating the "James Blackwell House", 1066 Armour Road, in the City of Peterborough, pursuant to the Ontario Heritage Act, 1974;

AND WHEREAS the Council of the City of the City of Peterborough deems it appropriate to authorize an amendment to the legal description of the lands contained in By-law 1983-51 to facilitate the severance of a vacant portion of the said lands.

NOW THEREFORE THE CORPORATION OF THE CITY OF PETERBOROUGH BY THE COUNCIL THEREOF HEREBY ENACTS AS FOLLOWS:


1. That section 1(b) of by-law 1983-51 is amended by deleting the metes and bounds property description therefrom and substituting the following property description therefor:

Part Block G, Registered Plan 12G, formerly in the Township of Douro, now in the City of Peterborough, County of Peterborough, more particularly described as Part 2 on Reference Plan 45R 8474, deposited September 13, 1990.

By-law read a first and second time this 24th day of September, 1990.

By-law read a third time and finally passed this 24th day of September, 1990.





