NOTICE OF INTENTION TO DESIGNATE

IN THE MATTER OF THE ONTARIO HERITAGE ACT, R.S.O. 1990 CHAPTER 0.18 as amended and in the matter of the property known as COOKE HOUSE located at 34 King Street South, being Part of North Half of Lot 24, Concession 14 in the Town of Innisfil, County of Simcoe, in the Province of Ontario. TAKE NOTICE that the Council for The Corporation of the Town of Innisfil intends to designate COOKES HOUSE under Part IV of The Ontario Heritage Act, R.S.O. 1990, c.0.18, as amended.

Statement of Cultural Heritage Value or Interest

COOKE HOUSE, also known as 'Ravenscriag' has been a prominent fixture in the village of Cookstown since its construction. The property sits on what was the original 160 acre farmstead owned by Thomas Cooke and his wife Mary Ann (nee Kidd), who played an important role in the early development of the village, including the source of its name – 'Cookes Town'. The existing property was built in 1868 by their son Christopher, who became a local Justice of the Peace and achieved the rank of Major in the Simcoe Foresters during the Fenian Raids and Northwest Rebellion. He also served as Warden of Simcoe County in 1880.

Heritage Attributes

- 1) All of the brick work in its naturally weathered state
- 2) The central tower, including
 - a. Cornice brackets
 - b. The third floor original window sash
 - c. The third floor Juliette balcony, with one surviving wall post and the 2 supporting backets
 - d. The main entrance with original transom of etched glass in a floral patter
- 3) The flanking recessed bayed sections:
 - a. The 2 story attic gables, including the eve brackets
 - b. The original attic window sash
 - c. The original carved gable faces
- 4) South elevation bay window with eve brackets
- 5) All window openings show segmented window heads.
