THE CORPORATION OF THE TOWNSHIP OF NORTH HURON

BY-LAW NO. 06-2021

Being a By-law to repeal By-law No. 1748(1983) of the Town of Wingham and to de-designate 104 Patrick Street East, Wingham.

WHEREAS the Council of the Corporation of the Town of Wingham enacted By-law No. 1748(1983) on November 7, 1983 designating 104 Patrick Street East, Wingham Ontario, to be of historic and architectural value and interest, pursuant to Section 29 of the *Ontario Heritage Act*;

AND WHEREAS Subsection 31.(1) of the *Ontario Heritage Act* authorizes the Council of a municipality to, repeal a By-law, or part thereof, designating property made under Section 29 of the *Ontario Heritage Act*;

AND WHEREAS the Council of the Corporation of the Township of North Huron has deemed the subject property as no longer having historic and architectural value and interest and is desirous of repealing By-law No. 1748(1983) of the Town of Wingham and de-designating 104 Patrick Street East, Wingham Ontario;

AND WHEREAS the Council of the Corporation of the Township of North Huron has caused such Notice of Intention to repeal heritage designating By-law No. 1748(1983) of the Town of Wingham to be served upon the property owner and the Ontario Heritage Trust and published in a newspaper having general circulation in the Township;

AND WHEREAS no Notice of Objection to the said proposed repeal of the heritage designating By-law No. 1748(1983) of the Town of Wingham has been served upon the Clerk of the Township;

NOW THEREFORE the Council of the Corporation of the Township of North Huron ENACTS the following:

1. That By-law No. 1748(1983) of the Town of Wingham is hereby repealed and the property identified as 104 Patrick Street East, Wingham Ontario is hereby de-designated and deemed to have no further historic and architectural value and interest under the *Ontario Heritage Act*.
2. That any By-laws, motions, or resolutions inconsistent with the provisions hereof are hereby repealed.
3. That this By-law shall come into force and takes effect on the day of the final passing thereof.

READ A FIRST AND SECOND TIME THIS 1ST DAY OF FEBRUARY, 2021.

READ A THIRD TIME AND PASSED THIS 1ST DAY OF FEBRUARY, 2021.
