
This letter is to advise Ontario Heritage Trust that upon review of By-law No. 2000-023 an error was noted with respect to the address of St. John’s Evangelist Roman Catholic Church.

The Council of the Town of Gananoque passed By-law No. 2021-015 (attached), to amend By-law No. 2000-023, being a by-law to designate the building know as St. John’s Evangelist Roman Catholic Church to remove “**262 Stone Street South**” and replace with the correct address of “**270 Stone Street South**”.

Of note, a Notice of Intention to Amend St. John’s Church has been issued with the corrected address (see email correspondence forwarded to OHT entitled “Town of Gananoque – Notice of Intention to Amend Eight (8) Heritage Designation”, dated February 5, 2021.

BY-LAW NO. 2021-015**

**BEING A BY-LAW TO AMEND BY-LAW NO. 2000-023, BEING A BY-LAW TO DESIGNATE ST. JOHNS EVANGELIST ROMAN CATHOLIC CHURCH, TO REMOVE "262 STONE STREET SOUTH" AND REPLACE WITH THE CORRECT ADDRESS OF "270 STONE STREET SOUTH"**

---

**WHEREAS** the *Ontario Heritage Act*, Section 29, states that the Council of a municipality may, by by-law, designate a property within the municipality to be of cultural heritage value or interest;

**AND WHEREAS** on August 8, 2000, By-law No. 2000-023, was passed to designate the building known as St. Johns Evangelist Roman Catholic Church, located at 262 Stone Street South on Stone Street South, Gananoque, as being of architectural and historical value;

**AND WHEREAS** the Council of the Town of Gananoque received Council Report CS-2021-07 and concurs with the recommendation to amend By-law No. 2000-023 to removed the incorrect address of "**262 Stone Street South**", in its entirety and replace with "**270 Stone Street South**", being the correct address for St. Johns Evangelist Roman Catholic Church;

**AND WHEREAS** the Council of the Corporation of the Town of Gananoque deems it appropriate to pass such a By-law.

**NOW THEREFORE** be it resolved that the Council of the Corporation of the Town of Gananoque enacts as follows:


**1. AUTHORIZATION:**

- 1.1. That By-law No. 2000-023, be amended to remove in its entirety the incorrect address of "**262 Stone Street South**" in its entirety and replace with "**270 Stone Street South**", being the correct address for St. Johns Evangelist Roman Catholic Church.

**2. EFFECTIVE DATE:**


- 2.1. This By-law shall come into full force and effect on the date it is passed by Council.
