Re: By-law to repeal Heritage Designation By-law for Giffin-McKane House, East Half Lot 27, Concession 2 EHS (former Chinguacousy Township), Town of Caledon, known municipally as 3831 King Street, Campbell's Cross

A recent file review indicated that By-law No. 92-62, designating the above-mentioned property under section 29 of the Ontario Heritage Act, had not been repealed following issuance of a demolition permit for the property in 1997.

Accordingly, pursuant to subsection 34.3 (2) of the *Ontario Heritage Act*, you are hereby served with a copy of By-law No. 2010-141, as amended by By-law No. 2010-165, passed by the Council for the Corporation of the Town of Caledon for the purpose of repealing By-law No. 92-62. 
A by-law to repeal Section 1(e) of By-law No. 92-02

WHEREAS on 21 September 2010 the Council of The Corporation of the Town of Caledon enacted By-law No. 92-02 designating, by Section 1(e), the Giffin-McKane House as being of architectural and/or historical value or interest pursuant to the *Ontario Heritage Act*;

AND WHEREAS, the Giffin-McKane House located on premises legally described as East Half Lot 27, Concession 2 E.H.S. (Ching.) was demolished in 1997 by Catholic Cemeteries – Archdiocese of Toronto;

NOW THEREFORE the Council for The Corporation of the Town of Caledon enacts that Section 1(e) of By-law 92-02 shall be and is hereby repealed.
