BY-LAW 925-2021

To amend By-law 238-2020, being a by-law to designate the property at 90 Croatia Street (980 Dufferin Street) as being of cultural heritage value or interest.

Whereas the Ontario Heritage Act authorizes the Council of a municipality to amend designating by-laws to correct the legal description of the property; and

Whereas at its meeting on September 30, October 1 and 2, 2020 authority was granted by Council of the City of Toronto to amend designating By-law 238-2020 dated February 26, 2020 to correct the legal description of the property and to reference the complete municipal address, being 90 Croatia Street (980 Dufferin Street) in the amending by-law; and

Whereas the amended legal description is set out in Schedule A to this by-law; and

Whereas the Council of the City of Toronto has caused to be served upon the owners of the land and premises known as 90 Croatia Street (980 Dufferin Street) and upon the Ontario Heritage Trust, Notice of Intention to amend By-law 238-2020, and has caused the Notice of Intention to amend By-law 238-2020 to be posted on the City's website for a period of 30 days in accordance with Municipal Code Chapter 162, Notice, Public, Article II, § 162-4.1, Notice requirements under the Ontario Heritage Act; and

Whereas no notice of objection was served upon the Clerk of the City of Toronto;

The Council of the City of Toronto enacts:

1. By-law 238-2020 is amended as follows:
 - a. reference to the property municipally known as "90 Croatia Street" throughout the by-law shall be amended by including reference to "980 Dufferin Street" so that the entire municipal address of the property reads:

"90 Croatia Street (980 Dufferin Street)"; and
 - b. the legal description set out in Schedule B of By-law 238-2020, which is reproduced in Schedule B to this by-law, is deleted and replaced with the legal description set out in Schedule A to this by-law.
2. The City Clerk is authorized to cause a copy of this by-law to be served upon the owner of the property located at 90 Croatia Street (980 Dufferin Street) as described in Schedule A to this by-law, the owner of the property located at 90 Croatia Street as described in Schedule B to this by-law and upon the Ontario Heritage Trust, and to cause notice of this by-law to be posted on the City's website for a period of 30 days in accordance with

Municipal Code Chapter 162, Notice, Public, Article II, § 162-4.1, Notice requirements under the Ontario Heritage Act.

3. The City Solicitor is authorized to cause a copy of this by-law to be registered against the property described in each of Schedule A and Schedule B to this by-law in the proper Land Registry Office.
