**NOTICE OF PROPOSED AMENDMENT  
TO HERITAGE DESIGNATION BY-LAW 918-86  
in the Township of North Dumfries, pursuant to  
section 30.1 of the *Ontario Heritage Act*, R.S.O. 1990, c. O.18 (the “*Act*”)**

NOTICE IS HEREBY GIVEN that Council of the Township of North Dumfries intends to amend By-Law No. 918-86, being the by-law designating the property municipality known as 2596 Alps Road, Reidsville, as a property of cultural heritage value or interest in accordance with the *Act*.

**Purpose and Effect of Proposed Amendment**

The proposed amendment will have the effect of continuing the heritage designation only of the property legally described as follows (the “**Designated Lands**”):

PART LOT 30 CONCESSION 10 NORTH DUMFRIES, PARTS 1 AND 3 PLAN 58R21178; SUBJECT TO AN EASEMENT OVER PART 3, PLAN 58R21178 AS IN WR39896; TOWNSHIP OF NORTH DUMFRIES (PIN 03851-0234)

The purposes of the proposed amendment of By-Law No. 918-86 are to:

1. clarify the statement explaining the cultural heritage value or interest of the Designated Lands and the description of their heritage attributes;
2. correct the legal description of the Designated Lands; and
3. otherwise revise By-law 918-86 to make it consistent with the requirements of the *Act* or its regulations.

The proposed amending by-law is available for review by request to the Clerk’s Office of the Township. A general description of the Designated Lands and their cultural heritage value or interest is set out in Schedule “A” to the proposed amending by-law.

Further information respecting this Notice of Proposed Amendment is available from the Clerk’s Office.

**Right to Object**

Any notice of objection, setting out the reason for objection and all relevant facts, must be served upon the Township Clerk within 30 days after the first publication of this Notice.
