NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the City of Cambridge
intends to designate the exterior of the following property for its
historical and architectural significance, under Part IV of the Ontario
Heritage Act, R.S.O. 1990, Chapter 0.18.

60 Middleton Street
The Middleton Water Pumping Station

This property is recommended for designation because of its historical and
architectural significance to the community. The Middleton Water Pumping
Station, constructed in 1890-91, was the first such station in the City.
The pump house is an excellent example of a public utility building that
did not sacrifice a pleasing appearance for the sake of practicality. The
pumping station has been in continuous use since it was designed by Willis
Chipman, the town engineer of Galt.

ANY PERSON MAY, within thirty days of the first publication of this
notice, send by registered mail or deliver to the Clerk of the City of
Cambridge, notice of his/her objection to the proposed designation
together with a statement of the reasons for the objection and all
relevant facts. If such a notice is received, the Council of the
Corporation of the City of Cambridge shall refer the matter to the
Conservation Review Board for a hearing.
