BY-LAW NO. 1767

OF THE

CORPORATION OF THE CITY OF CAMBRIDGE

A by-law to designate The Free Church Manse, 8 Haddington Street (also known as 8 Samuelson Street), Cambridge, Ontario, as being of architectural value and of historic interest.

WHEREAS The Ontario Heritage Act, 1974, authorizes the Council of a municipality to enact by-laws to designate real property including all buildings and structures thereon, to be of historic or architectural value or interest; and

WHEREAS Notice of Intention to so designate The Free Church Manse, 8 Haddington Street (also known as 8 Samuelson Street)

Cambridge, Ontario, has been duly published and served; and

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF CAMBRIDGE ENACTS AS FOLLOWS:

- There is designated as being of architectural and historic value or interest, the exterior of the vernacular classical granite house of the period, located on the real property, more particularly described in Schedule 'A' attached hereto, known as The Free Church Manse, 8 Haddington Street (also known as 8 Samuelson Street), Cambridge, Ontario.
- 2. The City of Cambridge is hereby authorized to cause a copy of this by-law to be served upon the owner of the said property and upon The Ontario Heritage Foundation and to cause notice of this by-law to be published in a newspaper having general circulation in the City of Cambridge.

SCHEDULE "A" TO BY-LAW NO. 1767

OF THE

CORPORATION OF THE CITY OF CAMBRIDGE

ALL AND SINGULAR that certain parcel or tract of land and premises, situate, lying and being in the City of Cambridge, in the Regional Municipality of Waterloo (formerly in the City of Galt), and being composed of Lot 3, Part of Lot 2 and Part of Lot 4, Registered Plan 440, known municipally as The Free Church Manse, 8 Haddington Street (also known as 8 Samuelson Street), Cambridge, Ontario.

SCHEDULE "B" TO BY-LAW NO. 1767

OF THE

CORPORATION OF THE CITY OF CAMBRIDGE

The Free Church Manse, 8 Haddington Street, (also known as 8 Samuelson Street), is designated for architectural and historial reasons.

The house bears the date "1854" and represents a vernacular classical, granite house of the period. Its six over six panes, double sash windows with stone sills and voussoirs and louvered shutters, and its long verandahs supported by pairs of fluted pillars look on well treed grounds. It is located next to "Caverhill", another distinguished stone house of the period.

The building owes its historical significance to those prominent people who are associated with it: Adam Ainslie, a lawyer and last Reeve of the Village of Galt; James Ainslie, a printer and manager of early local newspapers; and the Reverends John Thompson, D.D., and James K. Smith, ministers of Knox's Free Presbyterian Church, of which it served as manse from 1862 - 1884.
