### BY-LAW NO. 221-83

### OF THE

# CORPORATION OF THE CITY OF CAMBRIDGE

Being a by-law of the City of Cambridge to designate 56-58 Cambridge Street, Cambridge, Ontario, as being of historical value or interest.

WHEREAS The Ontario Heritage Act, R.S.O. 1980, Chapter 337, authorizes the Council of a municipality to enact by-laws to designate real property including all buildings and structures thereon, to be of historic or architectural value or interest;

AND WHEREAS Notice of Intention to so designate the property, including lands and buildings, known municipally as 56-58 Cambridge Street, Cambridge, Ontario, has been duly published and served;

AND WHEREAS it is considered desirable to designate the property known municipally as 56-58 Cambridge Street, Cambridge, Ontario.


NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF CAMBRIDGE ENACTS AS FOLLOWS :-

- There is designated as being of historical value or interest, the exterior 1. of 56-58 Cambridge Street, more particularly described in Schedule "A" attached to and forming part of this by-law. The reasons for the designation are set out in Schedule "B" attached to and forming part of this by-law.
- The City of Cambridge is hereby authorized to cause copy of this by-law to 2. be served upon the owner of the said property and upon the Ontario Heritage Foundation and to cause notice of this by-law to be published in a newspaper having general circulation of the City of Cambridge.

## SCHEDULE "A"

TO BY-LAW NO. 221-83

OF THE

CORPORATION OF THE CITY OF CAMBRIDGE

ALL AND SINGULAR that certain parcel or tract of land and premises, situate, lying and being, in the City of Cambridge, in the Regional Municipality of Waterloo and Province of Ontario, (formerly in the City of Galt), and being composed of Lot 8, Plan 444.

## SCHEDULE "B"

#### TO BY-LAW NO. 221-83

### OF THE

### CORPORATION OF THE CITY OF CAMBRIDGE

The "Old Township Hall" is designated for historic reasons.

The building was erected in 1838 by Alexander Scrimger, Carpenter, and Duncan Shepherd, who did the interior work. It served as the Township Hall of Dumfries until that township was divided in two by the creation of Waterloo and Brant Counties. Originally thought to have been a tall narrow clapboard building, it has since been much altered, although still retaining the general shape that gave it the name "Noah's Ark".

The building served as the first home of many early organizations and institutions such as Galt Collegiate Institute, Trinity Church, an early library and theatre group, as well as the seat of local government. It is said that the first of Lord Durham's meetings to be held outside of Toronto, inquiring into the causes of the 1937 Rebellion, was held here.

The building was replaced as the seat of local government when the new Town Hall was built in 1857, and moved to its present location on Cambridge Street at that time.
