



#### BY-LAW NO. 95 - 84

OF THE

CORPORATION OF THE CITY OF CAMBRIDGE

Being a by-law of the City of Cambridge to designate the exterior of the Pioneer Pergola in St. Andrews Park on St. Andrews Street as a property of historical significance.

WHEREAS the Ontario Heritage Act, R.S.O., 1980, c. 337 authorizes the Council of the municipality to enact by-laws to designate real property including all buildings and structures thereon, to be of historic or architectural value or interest;

AND WHEREAS Notices of Intention to so designate the "Pioneer Pergola" in St. Andrews Park on St. Andrews Street, Cambridge, Ontario, have been duly published and served and no objections have been received;

AND WHEREAS it is considered desirable to designate the property known as the "Pioneer Pergola" in St. Andrews Park;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF CAMBRIDGE ENACTS AS FOLLOWS:-

- 1. THAT there is designated as being of historical significance the exterior of the original structure located on the real property, more particularly described in Schedule "A" attached hereto, known as the "Pioneer Pergola" in St. Andrews Park, Cambridge, Ontario. The reasons for designation are set out in Schedule "B" attached hereto.
- 2. THAT the City of Cambridge is hereby authorized to cause a copy of this by-law to be served upon the owner of the said property and upon the Ontario Heritage Foundation and to cause notice of this by-law to be published in a newspaper having general circulation in the City of Cambridge.

Pioneer Pergola, St. Andrews Park

Reasons for Designation

The Pioneer Pergola is recommended for designation as being of historical significance because it incorporates a collection of gravestones of some of the earliest settlers of the Town of Galt. Built for that purpose by the Waterloo Chapter of the Imperial Order of Daughters of the Empire in 1907, it is the only monument to the pioneers which exists in the former City of Galt. The names and dates of birth and death of 207 people are recorded in this small structure.
