RE: Notice of Withdrawal and Re-Issued Notice of Intent to Designate 125-127 Dunlop Street East a Heritage Property under the Ontario Heritage Act

Ms.

Please be advised that the Notice of Intent to Designate 125-127 Dunlop Street East as a Heritage Property under the *Ontario Heritage Act* (OHA) has been **withdrawn**, as a designating By-Law could not be passed within the prescribed timelines. A new Notice of Intent to Designate has been **re-issued** to re-start the process of designating this property. The Notice of Withdrawal and re-issued Notice of Intent to Designate are attached for your reference.

The designation of this property is being facilitated by the Heritage Barrie Committee as per your request. As required by the OHA, a Notice of Intent to Designate was issued in the local paper on February 16, 2023. Further, a notice is being provided to the Ontario Heritage Trust, as required by the OHA.

The OHA states that the members of the public, as well as the owner, have 30 days from the day the Notice of Intent to Designate is issued to object to the designation. Council must pass a by-law to designate the property within 120 days from the day the Notice of Intent was published.

No action is required on your part at this time unless you wish to object to the designation. If no objections to the proposed designation are received within the 30-day period, staff will present a report to Council recommending the designation. This is anticipated to occur at the March 22, 2023 Council meeting.
