Please be advised that the Council of the Corporation of the Township of Selwyn intends to designate 2488 Hiawatha Lane, Smith Ward - CON 14 PT LOT 44 in accordance with the Ontario Heritage Act, R.S.O. 1990, c.0.18. The reason for the designation is to recognize the cultural heritage value or interest of portions of the property (see enclosed map).

## Notice of the Intention to Designate Property Under the Ontario Heritage Act

Take Notice That the Council of the Township of Selwyn plans to pass a By-law on the 13th of February 2024, under Section 29(1) of the Ontario Heritage Act, for the property described as follows:

### 2488 Hiawatha Lane (Kawartha Park Chapel)

Kawartha Park Chapel (2488 Hiawatha Lane) is an important and unique example of an early twentieth century cottage community church. Reflecting its non-denominational background, the simplicity of design reflects the church's mandate. Constructed in 1925, the Chapel demonstrates various heritage attributes that apply to all elevation including the roof, facades, entrances, windows chimneys and trim.
