By-Law Number 2023 - 47

Being a By-law to Repeal a Heritage Designation By-law

Whereas Part IV of the Ontario Heritage Act authorizes Councils to enact By-laws to repeal By-laws designating real property under the Ontario Heritage Act;

And Whereas the Council of the former Township of Collingwood had previously passed By-law 90-33, designating real property known as 417014 10th Line to be of Historical and Architectural interest;

And Whereas it has been requested by the owner of 417014 10th Line that the remaining Dwelling on the property be demolished;

And Whereas Council of the Town of The Blue Mountains considered staff report PDS.21.001 Update Report -Application to Demolish a Dwelling on a Cultural Heritage Designated Property - (Valleyview Construction), staff report PDS.21.050 named Update on an Application to Demolish Designated Heritage Dwelling (417014 10th Line), staff report PDS.21.079 named Recommendation Report — Request to Demolish a Designated Heritage Dwelling at 417014 10th Line (Mitchell Farm), and staff report PDS.23.054 named Recommendation Report — Request to repeal the Heritage Designated By-law 90-33 for 417014 10th Line (Mitchell Farm);

And Whereas the Council of the Town of The Blue Mountains deemed it in the public interest to approve a Heritage Permit to allow the Dwelling to be demolished;

And Whereas there are no remaining Cultural Heritage Attributes on the lands;

Now Therefore Council of The Corporation of the Town of The Blue Mountains hereby enacts as follows:

- By-law 90-33, pertaining to the lands known as 417014 10th Line, Clarksburg and legally as Part 2 of Reference Plan 16R-623, East Part of Lot 31, Concession 11, formerly the Township of Collingwood, is hereby repealed.
- The Municipal solicitor is authorized to cause a copy of this By-law to be registered on the property described in Schedule "A" hereto in the Land Registry Office.
- The Clerk is authorized to cause a copy of this By-law to be served upon the owners of the property affected by this By-law and upon the Ontario Heritage Foundation, to cause notice of the passing of this By-law to be public in a newspaper having general circulation in the municipality, and to delete the designation from the Municipal Heritage Register.
- 4. That the attached Schedule "A" forms part of this By-law.

And Further that this By-law shall come into force and take effect upon the enactment thereof.
